Therefore, the user agency is requested to make payment into concerned account and submit the copy of the remittance particulars along with compliance report to this office for taking further action

**I. (a) Procedure of e-challan generation:**

- i. On issue of the demand notice, the user agency shall log into Parivesh portal to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**II. (b) Procedure of payment through RTGS:**

- i. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a bank of his choice along with printed e-challan with an Account number printed on it.
- ii. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- iii. Upon executing the RTGS by the sender / remitter bank, the amount collected will be credited to relevant CAMPA State account with in the Bank on real time basis.
