Copy of the reference 1st & 2 nd cited on 07.12.2022 enclose herewith. In the reference 1st cited, The Additional Chief Secretary to Government has accorded State Government's in principal approval Proposal for diversion of 0.858 ha of forest land in formation of road between K.S.Road to Manali through Manali RF in a length of 1430m and width 6.00m in Tiruvallur forest division in Tiruvallur District in favour of the Block Development Officer, Gummidipoondi Tiruvallur District in favour of the Block Development Officer, Gummidipoondi Tiruvallur District, Stipulating certain conditions.

- 1. As per the condition (b), demarcation of the proposed forest areas shall be carried out by erecting 4 feet height cement concrete pillar duly numbered at an interval of 20 meters at the cost of user agency before stage-II approval. It is therefore requested that the demarcation of the boundary may be carried out immediately as stipulated by Additional Chief Secretary to Government Environment, Climate Change & Forests by proper intimation to this office.
- 2. As per the condition (c), the User Agency has to pay the Net Present value of proposed forest diversion area which will be fixed as per the guidelines of Hon'ble Supreme Court of India / Government of India.
- 3. As per the condition (d), The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by forest department in future. The user agency has to furnish undertaking to this effect.
- 4. As per the condition (e), the User Agency is requested to pay an amount of Rs.739073/- towards the Net present Value for 0.858 Ha of Forest land diverted in Manali Reserved Forest. The amount shall be deposited to CAMPA account by generating online challan for making payment through e- portal (https://parivesh.nic.in)
- 5. The user agency is requested to furnish undertakings as per the conditions c, d, f, g, h, i, j, k, as mentioned in the Additional Chief Secretary to Government Environment, Climate Change & Forests (FR.10) Department, Secretariat, Chennai. Letter No.12536/FR-10/2022-1 Dt: 26.08.2022.

As the compliance report has to be sent to the Government through Principal Chief Conservator of Forests (HoD), Chennai for final approval, the user agency is requested to comply with the conditions, furnish the required undertakings and pay the Net Present Value of the forest land as mentioned in para. No.4 above.
