Sub: APFD - F (C) Act,1980 - Diversion of 11.38 ha of Forest land in Visakhapatnam Division for laying 400/220 KV overhead Transmission line from 400/220 KV Kalapaka sub-station to the proposed cable pot head station for HPCL Refinery at Visakhapatnam in f/o CGM (Projects) (VRMP), HPCL, Visakhapatnam - In-principle (Stage-I) approval accorded - Order communicated by the PCCF - Compliance report called for - Demand notice - Regarding.

It is submitted that, in the reference cited, the Prl.Chief Conservator of Forests & HoFF, A.P. Guntur has communicated in-principle (Stage-I) approval for diversion of 11.38 ha of Forest land in Visakhapatnam Division for laying 400/220 KV overhead Transmission line from 400/220 KV Kalapaka sub-station to the proposed cable pot head station for HPCL Refinery at Visakhapatnam in f/o CGM (Projects) (VRMP), HPCL, Visakhapatnam.

In this connection, the CGM (Projects) (VRMP), HPCL, Visakhapatnam is requested to go through the conditions stipulated in Conditions from 1 to 22 but the compliance in form of undertaking shall be submitted prior to Stage-II approval and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur without any deviation.

The Pri.Chief Conservator of Forests (HoFF) A.P. Guntur has instructed to issue demand notice to the user agency in the proforma communicated in Rc.no.45921/2001/FCA-4, dt:22.12.2017 for payment of NPV, CA etc., amounts to Adhoc-CAMPA through **e-payment mode i.e. challan generated through the Ministry's web portal (i.e. www.parivesh.nic.in) only**, as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter, dt:09.06.2016. The payment shall be made only in Corporation Bank.

I. Amount demanded to be deposited in Adhoc CAMPA, Corporation Bank, Lodhi Road, New Delhi through e-challan only.

***As per the condition no.7:** Considering violation of FCA 1980, action required to be taken on User Agency / Forest Department officials are as follows.

a. For works carried out in violation of FCA, 1980 by the UA over an extent of 6.00 ha, as recommended by the REC, penalty (Penal NPV) of 2 times of NPV plus 12 percent simple interest till the deposit is made for an area of 6.00 ha as per provisions made in the comprehensive hand book under section 1.21 (ii) (a) and as the user agency is a Central PSU, 20% of the above mentioned penalty shall be charged as per the provisions made in the comprehensive hand book under section 1.21 (ii) (b);

The user agency should pay the Net Present Value (NPV) and Penal Net present Value (Penal NPV) Compensatory Afforestation (CA) and Rs. **185.43930 lakh** for the diverted forest land shall be deposited in CAMPA account, Corporation Bank, CGO Complex, Lodhi Road, New Delhi - 110003 (RTGS / IFSC no. CORP0000371) and submit the receipts along with the compliance report to the conditions stipulated in the references cited point wise for onward submission to the Chief Conservator of Forests / Conservator of Forests, Visakhapatnam for further action in the matter

II. Amount demanded for Tree extraction, logging and transportation in the forest area diverted to be deposited with Divisional Forest Officer
