Sir/Madam,

With reference to the subject cited above, and on thorough perusal of your proposal it is learnt that your project involves laying of underground optical fibre able through horizontal directional drilling and it does not involve any felling of trees and falls outside National Parks/ Sanctuary areas. Thus, as per point (xi) of para-4 File No. 5-3/2011-FC(Vol-I), dtd. 6/01/2022 of Ministry of Environment, Forest and Climate Change, Govt of India, for the above-mentioned category, the Net Present Value (NPV) is fully exempted.

I this regard, for further processing your proposal, you are hereby requested to submit a compliance report on all the conditions from Sl. No. (i) to (xiv) along with necessary undertaking as being stipulated in the letter under reference (1). In addition to this, you are hereby requested to deposit 2% of the estimated project cost for Human-Elephant/ Wildlife Conflict Mitigation & Wildlife Conservation Plan to the corpus fund account of Chief Wildlife Warden, Assam and to provide proof of payment for the same to the undersigned for onward necessary action.

Sir,

I am directed to invite your attention to Hon'ble Supreme Court's order dated 28.03.2008 in Writ Petition (Civil) No. 202 of 1996 in the matter of T. N. Godavarman Thirumalpad vs. Union of India and Ministry' guidelines dated 05.02.2009 wherein rates to Net Present Value (NPV) to be realized in lieu of diversion of forest land have been fixed based on the outcome scientific assessment of ecosystem goods and services. Hon'ble Supreme Court in the said order has also directed the MoEF&CC for upward revision of the NPV rates.

2. In compliance of order dated 28.03.2008 of Hon'ble Court and with the approval of the competent authority, the following revised NPV rates have been prescribed for levying NPV in lieu of diversion of forest land:

- 3. NPV shall be charged to the extent of ten times of the normal NPV payable in the case of National Parks and five times in the case of Sanctuaries. The use of non-forest land falling within the National Parks and Wildlife Sanctuaries may be permitted on payment of an amount equal to the NPV payable for the adjoining forest area. In respect of non-forest land falling within marine National Parks / Wildlife Sanctuaries, the amount shall be five times the NPV payable for the adjoining forest area;

Forest Diversion proposal of 0.96 ha forest land for lying of Optical Fiber Cable

(OFC) in Dessoi Valley Reserved Forest under Jorhat Division in favour of

Telesonic Network Limited.

Sir,

This has got reference to the letter No.FG.27/FCA/Proposal/OFC/Jorhat Division dated 17.02.2023 of O/o the PCCF & HoFF, Assam on the subject mentioned above, seeking prior approval of the State Government in accordance with General Approval under section 2(ii) of FCA, 1980 and in terms of the "Handbook of the Forest (Conservation) Act, 1980 and the Forest Conservation Rules, 2003 (Guidelines & Clarification), MoEF & CC, GoI, 2019" mentioned under Chapter-4 (para 4.1, 4.2, 4.3 and 4.3.1).

After careful consideration of the proposal of the PCCF & HoFF, Assam, I am directed to inform that the Government of Assam hereby conveys its "In- Principle Approval" for diversion of 0.96 ha forest land for laying of Optical Fiber Cable (OFC) in Dessoi Valley Reserved Forest under Jorhat Division in favour of Telesonic Network Limited subject to the following conditions:

- i. The forest area involved is not within a National Park and/or a Wild Life Sanctuary.
- ii. User Agency shall explore all feasible alternatives to minimize use of forest land.
- iii. Forest land to be used shall be restricted to the bare minimum and shall be used only when it is unavoidable.
- iv. The User Agency shall pay the applicable NPV in pursuance of the orders of the Hon'ble Supreme Court.
- v. The User Agency shall provide an undertaking for payment of additional NPV, if any.
- vi. In addition to monthly report of diversions of forest land under General Approval accorded by MoEF & CC, PCCF & HoFF, Assam shall submit half yearly reports for the period ending June 30 and December 31 containing details of all forest lands diverted under the General Approval along with the actual status of actual utilization of the forestlands so diverted for the stated purpose, to the MoEF & CC, Govt. of India and its concerned Regional Office with intimation to Government of Assam.

The diversions and compliance to the conditions will be monitore vii. by the PCCF & HoFF, Assam.

No tree felling is involved for the proposed work. viii.

After completion of the project the area under RoW should be ix. reclaimed suitably.

The user agency shall deposit 2% of the total project cost for Human Elephant Conflict mitigation and Wildlife Conservation X.

User Agency agrees to make good any loss to Forest/Environment. xi.

The User Agency will seek permission from the local Forest Official xii. for carrying out any maintenance.

In case, the proposed area falls in the RoW of the road passing xiii. through National Parks and Wildlife Sanctuaries, General Approval is to be obtained from the State Board for Wildlife.

In case, the proposed area falls in the RoW of the road passing xiv. through Tiger Reserves, General Approval is to be obtained from the National Board for Wildlife/NTCA.

After receipt of the compliance report from the PCCF & HoFF, Assam on fulfillment of the conditions mentioned above, final approval will be issued in this regard. Formal transfer of forest land shall not be effected by the PCCF & HoFF, Assam till final approval orders approving the diversion of forest land are issued by the Government of Assam.
