Sir,

The Ministry of Environment & Forests (MoEF) vide letter F.No.3-TR C 057/2021-SHI/1997-98 dated 30.11.2021 of Integrated Regional Office, MoEF & CC, Shillong has conveyed the "In-Principle Approval" for diversion of 82.6044 ha of forest land for widening / improvement of Lalcherra-Kanchanpur section of NH-44A to two laning with paved shoulders under Dhalai, Unakoti & North District subject to certain conditions.

2. As per the condition stipulated in the approval made by the Ministry against vide letter dated 30.11.2021, the **estimated** cost for Rs. 13,76,97,908/- (Rupees thirteen crore, seventy-six lakh, ninety-seven thousand, nine hundred and eight) only towards Net Present Value & Compensatory Afforestation & Cost for Avenue Plantation in compliance of conditions No.A.(1), (2) & (4) is enclosed.

3. The above mentioned fund is required to be transferred by the User Agency through online system in favour of the Compensatory Afforestation Fund (CAF), Tripura, Adhoc CAMPA, New Delhi of Corporation Bank, Block 11, CGO Complex, Phase-I, Lodhi Road, New Delhi-110 003 **through e-payment portal. Such payment is not accepted through any other mode w.e.f 31st March 2016.**

4. The User Agency will submit the original certified money receipt in compliance with the conditions as mentioned in para-2 above.

5. The User Agency shall furnish certificates/undertakings in compliance of condition at Sl.No.A.1 to A.15 and B.1 to 23.

The necessary steps can be taken for final approval under Section 2(ii) of Forest (Conservation) Act, 1980 on receipt of the same.
