With reference to the subject cited above on the captioned subject, it is to intimate that the financial out lay for Compensatory Afforestation Scheme over an area of **1.99 ha.** of non-forest private land identified in Village Kurumula under Pallahara Tahasil of Khamar Range of Deogarh Forest Division pertaining to the above project amounting to **Rs.7,62,000/- (Rupees Seven Lakhs Sixty-two Thousand)** only had been technically approved by PCCF (FD & NO, FC Act), Bhubaneswar at the wage rate of **Rs.308/-** per man days .

Similarly, the financial out lay for Additional Compensatory Afforestation Scheme over an area of **2.0 ha.** of degraded forest land identified in Charigochhia, RF under Khamar Range of Deogarh Forest Division pertaining to the above project amounting to **Rs.1,61,700/- (Rupees One Lakhs Sixty-one Thousand Seven Hundred)** only had been technically approved by PCCF (FD & NO, FC Act), Bhubaneswar at the wage rate of **Rs.308/-** per man days with 10 years maintenance. This fund was deposited by you vide **UTR No.SBINR 5202/0112062/4845 dt.12.01.2021 in ORRISA CAMPA bearing A/C No.1508219998250347** as communicated to this office vide your Letter No.ANGL/JSPL/SPL/2021/13 DT.12.03.2021.

In the meantime, due to the revision of wage rate from Rs.308/- MD to Rs.333/- MD, the cost of the above financial outlay of CA Scheme has been revised to **Rs.14,25,000/- (Rupees Fourteen Lakhs Twenty-five Thousand) only & Additional CA has been revised to Rs.2,27,300 (Rupees Two Lakhs Twenty-seven Thousand Three Hundred) only approved by PCCF (FD & NO, FC Act.)** O/o the PCCF & HoFF Odisha, Bhubaneswar.

Therefore, you are requested to deposit the differential amount of Rs.6,63,000/- (Rupees Six Lakhs Sixty-three Thousand) only (Rs. 14,25,000.00-7, 62,000.00) against CA & Rs.65,600/-(Rupees Sixty-five Thousand Six Hundred) only (Rs.2,27,300.00-1,61,700.00) against Additional CA for payment through web portal (<http://parivesh.nic.in>) of MoEF & CC and submit the deposit particulars to this office at early date for taking necessary action at this end.

With reference to memo cited above on the captioned subject, it is to inform you that the financial outlay for Site Specific Wildlife Conservation Plan pertaining to the above project amounting to **Rs.2,08,30,000/- (Rupees Two Crore Eighty Lakhs Thirty Thousand)** only & the financial outlay for Elephant Anti-depredation Scheme **Rs. 4,23,46,800/- (Rupees Four Crore Twenty Three Lakhs Forty-six Thousand Eight Hundred)** only had been approved by PCCF (WL) & CWLW, Odisha, Bhubaneswar at the wage rate of Rs.326/- per Man Day with 10 years maintenance. However revision of wage rate from Rs.326/- MD to Rs.333/- MD, the cost for Elephant Anti-depredation Scheme has been revised to **Rs. 4,36,70,640/- (Rupees Four Crore Thirty Six Lakhs Seventy Thousand Six Hundred Forty) only.**


