With reference to above letter on the captioned subject, it is to inform you that as per technically approved Compensatory Afforestation Scheme of the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act vide their Memo No. 3303 dated 20.02.2023, the revised compensatory afforestation scheme amount comes for Rs. 45, 91, 300/- as per the wage rate of @ Rs. 333/MD with provision of planting of 18 months seedlings. You have already deposited the Compensatory Afforestation amount of Rs. 4509700/-. A copy of Technically Approved Compensatory Afforestation Scheme is enclosed herewith for your reference.

You are, therefore, requested to deposit the balance Compensatory Afforestation amount of Rs. 81,600/- i.e. (Rs. 4591300 - Rs. 4509700= Rs. 81600/-) through e-portal immediately and report the fact of deposit to the undersigned for taking further action at this end. After depositing the same, the revised statement of the funds towards compensatory levies in prescribed CAMPA format will be forwarded to the competent authority for processing of Stage-I compliance report.
