Diversion of 21.159 ha. of forest land in Deogarh Forest Division for construction of 220KV LILO Transmission line from Loc.331 of existing 220KV Rengalito Tarkera transmission line to the proposed 220/33 KV Grid Sub-Station at Sunamunda in Deogarh Division in Deogarh District by M/s Odisha power transmission Corporation Ltd. (OPTCL), Jharsuguda. Sir,

With reference to memo cited above on the captioned subject, it is to inform you that the Financial outlay for Dwarf Plantation Scheme over a length of 6.045 KM pertaining to the above project amounting to **Rs.52, 74,000/- (Rupees Fifty Two Lakhs Seventy Four Thousand)** only has been technically approved by RCCF, Rourkelaa at the wage rate of Rs.315/- per Man Day with 10 years maintenance . This fund had been deposited by you vide payment vide UTR No.SBINR 52020122403492887 dt.24.12.2020 in **ODISHA CAMPA Account bearing No.150826438533584 & SBIN 422144896937 dt.24.05.2022in ODISHA CAMPA bearing Account No.150826438533336** as communicated to this office vide your Letter No.1452(7) dt.24.12.2020 & Letter No.790 (6) dt.25.05.2022.

In the meantime, due to the revision of wage rate from Rs.315/- MD to Rs.333/- MD, the cost of the above financial outlay of Dwarf Plantation Scheme has been revised to **Rs. 54,46,350/- (One Fifty Three Lakhs Seventy Nine Thousand Three Hundred Twelve)** only.

Therefore, you are requested to deposit the differential amount of **Rs.1,72,350/- (Rupees One Lakh Seventy-Two Thousand Three Hundred Fifty Only (Rs.54,46,350.00-52,74,000.00))** against Dwarf Plantation for payment through web portal of MoEF & CC and submit the deposit particulars in CAMPA format to this office for taking further action at this end.
