In the reference 1st cited, The Additional Chief Secretary to Government has accorded State Government's in principal approval for diversion of 0.8514 ha of forest land in Erumaivettipalayam RF in Gummidipoondi Range of Tiruvallur Forest Division for upgradation of road from GNT road to New Erumaivettipalayam km 2/350-4/150 through the Erumaivettipalayam RF to a length of 1523m and triangle portion base length of 50m for 5.50m width road formation (BT surface and shoulder width) in Tiruvallur District in favour of Divisional Engineer, Highways Department, construction and maintenance, Tiruvallur, Stipulating certain conditions.

- 1. As per the condition (b), demarcation of the proposed forest areas shall be carried out by erecting 4 feet height cement concrete pillar duly numbered at an interval of 20 meters at the cost of user agency before stage-II approval. It is therefore requested that the demarcation of the boundary may be carried out immediately as stipulated by Additional Chief Secretary to Government Environment, Climate Change & Forests on proper intimation to this office.
- 2. As per the condition (c), the User Agency is requested provide full fledged chain link fencing on either side of the road to prevent trespassing into Reserve forest by miscreants as road is cutting through middle of reserve forest, at their cost, and the user agency to furnish an undertaking for the further maintenance of the chin link fencing as the responsibility lies with user agency for its further maintenance during the project diversion period.
- 3. As per the condition (d), the User Agency is requested to pay revised amount of Rs.7,33,387/- (Rupees Seven Lakhs Thirty three thousand and Three hundred and eighty seven only) towards the Net present Value for 0.8514 Ha of Forest land diverted in Erumaivettipalayam Reserved Forest. The amount shall be deposited to CAMPA account by generating online challan for making payment through e- portal (https://parivesh.nic.in)
- 4. As per the condition (e), the user the User Agency is requested to furnish an undertaking to bear the additional amount of the Net Present Value (NPV) for the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme court of India that will be fixed by the State Government / State forest Department in future.
- 5. The user agency is requested to furnish undertakings as per the conditions g, h, i, j, k, l, m as mentioned in the Additional Chief Secretary to Government Environment, Climate Change & Forests (FR.10) Department, Secretariat, Chennai. Letter No.21898/FR-10/2021-1 Dt: 09.02.2022.

As the compliance report has to be sent to the Government through Principal Chief Conservator of Forests (HoFF), Chennai for final approval, the user agency is requested to comply with the conditions, furnish the required undertakings and pay the Net Present Value of the forest land as mentioned in para. No.3 above.
