

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.) dated 3rd August 2009 where in the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is cert fied that **00.70Ha** of forest land in **R.S.No.225** of Halaki village in Savadatti taluk is proposed to bediverted in favour of **Executive Engineer**, **Public works**, port & Internal Water Transport **Department**, Gokak for the purpose of Construction of road from Hullikeri tanda to Halki falls within Jurisdiction of Halki village in Savadatti tehsils. It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 70Ha of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Divisional Level Committee(s) and the District Level Committee are enclosed as annexure (Nil) to (Nil) annexure.
- (b) The diversion of forest land for facilities managed by the Government as required under section 5 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it.

The proposal does not involve recognised rights of Primitive Tribal Groups and Pre-agricultural communities.
