**DEMAND NOTICE**

Sub: A.P.F.D. - Diversion of 1.24 hectares Forest land in Compartment No.402 of Kankanapalli R.F. for formation of road proposed from Roddavalasa to Kankanapalli of Pachipenta mandal in Vizianagaram District - In Principle (Stage-I) approval accorded - Payment of Net present value and C.A., to the Adhoc CAMPA account - Requested Regarding.

The Executive Engineer, Panchayat Raj (PIU), Vizianagaram is aware that the Government of India in the reference 1<sup>st</sup> cited have accorded in principle Stage-I approval for diversion of 1.24 hectares of Forest land for formation of road proposed from Roddavalasa to Kankanapalli of Pachipenta mandal in Vizianagaram Vizianagaram Forest Division in favour of Executive Engineer, Panchayat Raj (PIU), Vizianagaram with conditions to pay Net present value and Compensatory afforestation.

In this connection, as per the conditions stipulated in the stage-I approval and as per the instructions issued by the Prl. Chief Conservator of Forests, A.P. Guntur in the reference 3<sup>rd</sup> cited, the Executive Engineer, Panchayat Raj (PIU), Vizianagaram is requested to transfer or deposit the following amounts to CAMPA fund only through e-portal (<https://parivesh.nic.in/>) in connection with the diversion of 1.24 hectares of Forest land proposed for formation of road from Raipur to Visakhapatnam.

**1. Amount demanded to be deposited in Adhoc CAMPA Corporation Bank, New Delhi through e-challan only.**

**I (a) Procedure for e-challan generation:**

- i. On issue of this demand notice, the user agency shall log into Forest clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer i.e., Prl. Chief Conservator of Forests, A.P. Guntur for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

**I (b) procedure for payment through RTGS:**

- iv. For payment through RTGS, the representative of the agency ie., Project Director, NHAI, Vizianagaram should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender / remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

Further, it is informed that if any payment is made by any other method, the same shall not be considered for compliance towards Stage-I/II as per the guidelines issued in IGF, Ad-hoc, CAMPA, Lr.No.12-2/2010-CAMPA, dt: 14.04.2017.
