## Condition No.ii for erection of 4 feet high cement concrete pillars

As per the above condition it is requested that user agency should construct the cement concrete pillars with 20 cm x 20 cm size and 4 feet high above ground duly numbered at an interval of 20 meters at both sides.

# Condition No.iii-Compensatory Afforestation (CA over 1.00 ha)

As per the above condition it is requested that the user agency has to pay the cost towards compensatory Afforestation over an extent of degraded forest area as per the Compensatory Afforestation Scheme including maintenance for period of 10 years @ Rs.451132/-Condition No.v -Net Present Value

As per the above condition it is requested that the user agency has to pay the Net Present value of proposed forest diversion area an extent of 0.6996 ha @ Rs.781383/-

Condition No.vi - Human Wild life conflict Mitigation plan.

As per the above condition it is requested that the user agency has to pay the cost towards human wildlife conflict mitigation plan @ Rs.250000/-.
