In inviting a reference to the above, this is to inform you that, the Govt. of Assam vide letter no. FRS.92/2022/19 Dt. 11-07-2022 has conveyed the "In Principle Approval" for Forest Land Diversion of 0.0225 hectares of Forest Land for construction of Mobile Tower Location I-AS-SONY-ENB-9040 in Innerline Reserve Forest under Cachar Forest Division, Silchar by Reliance Jio Infocomm Limited subject to the compliance of certain condition as laid down in CCF & Nodal Officer's letter under reference.
