The Additional Principal Chief Conservator of Forests, Maharashtra State, Nagpur has submitted proposal for diversion of 8.4771 ha. of forest land for up-gradation and widening from existing 2 lane to 2 lane with Paved Shoulder configuration of Mudked-Bhokar NH-161 A Section from km 22.00 km 43.00 of 21.00 km length in Mudkhed & Bhokar Talukas of Nanded District in the State of Maharasthra.

The proposal has been initiated by the the Executive Engineer, P.W.Divsion Bhokar, 2. Dist. Nanded for seeking approval under Forest (Conservation) Act, 1980. The User Agency has given justification for locating the project in forest land that Mukhed-Bhokar Road National Highway-161A section from km 22.000 to 43.000 is currently 3.75 m wide road. The road to Bhokar is in bad condition at present. Since Bhokar is close to the Telangana border, the area observes heavy traffic for Nirmal, Mheasa, Adilabad and Kinwat. This traffic is obstructed due to narrow road warranting its up-gradation including improvement of highway geometrics. The National Highway Division has entrusted Public Works Department (PWD), Bhokar with the responsibility of up-gradation and widening of the above road section of NH-161A from km 22.000 to 43.000 of 21 km length. In the 21 km length. In the 21 km project alignment length, 2.80 km length is proposed to be upgraded to 4-lane configuration, 17.40 km to two-lane with paved shoulder configuration and remaining 0.80 km to Cement concrete within the villages. The proposed up-gradation is on the existing carriageway including realignments for improvement of highway geometrics that have been finalized after detailed site investigations, surveys and codal provisions. The requirement of additional area for the proposed up-gradation in some existing and re-alignment portions that are falling on the forest land which could not be avoided has been kept minimum. The total non-forest area involved in the project is 27.37 ha.

3. The Deputy Conservator of Forests, Nanded has certified that:-

- 3.1 No suitable alternate non-forest land is available and demand for the forest land is minimum.
- 3.2 Provisions of Forest (Conservation) Act, 1980 and guidelines under its have been violated in the proposed project. The detailed Violation report is enclosed in the proposal.
- 3.3 The proposed area belongs to Eco value class-III, Dense Forest having density below 0.04.
- 3.4 There are 1683 trees cutting and felling involved in the project.

- 3.5 The Painganga Wildlife Sanctuary is at an approximate radial distance of 42.76 km. from area proposed for diversion.
- 3.6 Proposed area is not included in National Park, Wild Life Sanctuary or Nature Reserve.
- 3.7 Proposed Compensatory Afforestation over 8.4771 ha. Non-Forest land at Village-Gundawal, Tehsil-Mahur, Range-Mahur Survey/Gut No.70. This area is suitable for afforestation and management purpose and also it is free from encroachment.
- 3.8 Proposed project is not likely to affect any monumental site of cultural, historical, religious, archeological or recreational importance.
- 3.9 The project is extremely site-specific and no alternative non-forest land can be used for the propose
- 3.10. CA Scheme for Ten years.

4. The User Agency has submitted undertakings:-

- 4.1 to bear the cost of exploitation of felling of trees and their allied works in forest land.
- 4.2 to bear the cost of Compensatory afforestation.
- 4.3 to bear the cost of Net Present Value.
- 4.4 Whatever Penalties will be imposed regarding the violation of the Forest (Conservation) Act, 1980 User Agency is ready to pay the same.
- 4.5 to pay the additional amount of NPV, if so, determined as per decision of the Hon'ble Supreme Court.

- 5. MoEF&CC has issued guidelines regarding processing of proposals involving ex-post facto approval vide letter dt.22.03.2022, accordingly proposal may be submitted to Ministry level (Head Quarter).
- 6. The Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur has recommended the proposal subject to the conditions, given in his specific recommendations, under Section-2 (ii) of the Forest (Conservation) Act, 1980. His specific recommendations are enclosed in the proposal.
- 7. In the circumstances explained in the aforesaid paragraphs and enclosures, the State Government recommends that the said forest land may be allowed to be diverted subject the conditions proposed by the Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur as well as following additional condition:-

"User Agency shall submit the Record of Rights (Gat No. 13 to 18), of proposed land for diversion before Stage-I approval."

The matter may kindly be placed before the Government of India for its approval under Section-2 (ii) of the Forest (Conservation) Act, 1980, be obtained and communicated to this Government.
