Subject : Proposal from RailTel Corporation of India, Valsad for diversion of 0.70362 Ha. of Protected Forest Land for laying of Optical Fibre Network in Sindoni, Mandoni and Khanvel villages in the U.T. of Dadra & Nagar Haveli.

Sir,

As per the powers conferred under reference above by the Ministry of Environment and Forests, New Delhi the request of the RailTel Corporation of India, Valsad for diversion of 0.70362 Ha. of Protected Forest land for laying of Optical Fiber Network at Sindoni, Mandoni and Khanvel villages in the U.T. of Dadra & Nagar Haveli is considered and in-principle approval is accorded subject to the following conditions:-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.
- ii No felling of tree shall be involved in the implementation of the proposal.
- iii The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.
- iv The pipeline shall be along the road within existing right of way not falling in National parks and Wildlife sanctuaries.
- v Compensatory Afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 years.

Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the Forest Department, DNH.

- vi The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.
- vii Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the U.T. Administration of Dadra & Nagar Haveli from the User Agency. The User Agency shall furnish an undertaking to this effect.
- viii The User agency shall seek permission from Forest Department, DNH for carrying out any maintenance;
- ix The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
- x All statutory provisions under various Acts, Rules there under and guidelines applicable to this project shall be strictly adhered to.
- xi The User Agency shall be transfer the fund to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank Account No.SBO1025204 (Compensatory Afforestation Fund (CAF) Dadra & Nagar Haveli in Corporation Bank, Lodhi Complex, New Delhi 110003.
- xii The user agency has to pay Rs.6,60,699/- (Rupees Six lakh, Sixty thousand, six hundred and ninety-nine only) towards Net Present Value of Land and Rs.8,23,555/- (Rupees Eight lakh, Twenty- three thousand, five hundred and fifty-five only) towards Compensatory Afforestation including maintenance for 10 years.
- xiii The forest land shall not be used for any purpose other than that specified in the proposal.

You are therefore, requested to deposit an amount of **Rs.14,84,254/- (Rupees: Fourteen Lakh, Eighty-four Thousand, Two Hundred and fifty-four only)** through challan generated through **Online mode** in favour of Compensatory Afforestation Fund(CAF) Dadra & Nagar Haveli and copy of proof /evidence may be submitted to this office. The User Agency shall adhere to all the conditions indicated above.

The formal order for diversion of forest land to User Agency will be issued only after above conditions are complied. In no case the work shall be started without a formal order from this office.
