You are requested to comply with all the Conditions and submit your point-wise comprehensive compliance for onward transmission to the Govt. at the earliest.



Further, you are requested to prepare necessary Schemes and submit the same to this office for approval immediately as prescribed in Condition No.A (vi).

1. The User Agency is requested to deposit ₹ **44,59,424/-** (3.104 ha. X ₹14,36,670/-) (Rupees Forty Four Lakh Fifty Nine Thousand Four Hundred Twenty Four) only towards Net Present Value (NPV) as per **Condition No.A (i)** of the Stage-I approval order within 30 days from the issue of this Letter.
2. The User Agency is requested to deposit ₹ **2,54,528/-** (3.104 ha. X ₹82,000/-) (Rupees Two Lakh Fifty Four Thousand Five Hundred Twenty Eight) only towards Regional Wildlife Management Plan fund as per **Condition No.A (viii)** of the Stage-I approval order.
3. The User Agency is requested to deposit ₹ **34,32,500/-** (Rupees Thirty Four Lakhs Thirty Two Thousand Five Hundred) only towards cost of Compensatory Afforestation.


