As per Serial No. i & vii of the stipulated condition you have to deposit the Net Present Value (NPV) of the Forest Land so diverted, the Forest Area is under Eco-Class No. IV, the amount of Net Present Value (NPV) for 13.233 Ha. X 4.38 Lakh/Per Ha. is comes to Rs. 57, 96, 054/- (Rupees Fifty seven lakh ninety six thousand fifty four) only. Also you have to deposit the Compensatory Afforestation amount, the amount of Compensatory Afforestation is comes to Rs. 39, 58, 600/- (Rupees Thirty nine lakh fifty eight thousand six hundred) only. A copy of Technically Approved Compensatory Afforestation Scheme by the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act is enclosed herewith for your reference.

It is, therefore, requested you to make the payment for the Net Present Value (NPV) amounting to Rs. 57, 96, 054/- (Rupees Fifty seven lakh ninety six thousand fifty four) only & Compensatory Afforestation for the above mentioned project amounting to Rs. 39, 58, 600/- (Rupees Thirty nine lakh fifty eight thousand six hundred) only, through online payment on web-portal of MoEF & CC (https://parivesh.nic.in/) immediately and report the undersigned about deposit of the same for taking further action at this end.

In inviting a reference to the above cited correspondence of Special Secretary to Govt., in FE&CC Deptt. to your address, you are requested to take necessary action in the matter at its earliest. The Financial outlay for CA Scheme over an area of 13.350 ha of non-forest Government land identified in village Phulagandhi under Chitrakonda Tahasil of Malkangir Forest Division amounting to Rs.39,58,600/- (Rupees Thirty-nine lakh fifty eight thousand six hundred) only has been technically approved by PCCF (FD & NO, FC Act) at the wage rate of Rs.315/- per man day with 10 years maintenance. The approved financial outlay of the above project is enclosed herewith for information and necessary action.

Further, you are requested to raise the demand of all the compensatory levies on the user agency for payment through web portal of MoEF & CC and submit the deposit particular (in prescribed CAMPA format) of the amount paid pertaining the above project.

In view of above, you are requested to furnish the required compliance as stipulated in Part-A (12 Nos. which need to be complied prior to handing over forest land by the State Forest Department & Part-B (15 nos which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval) conditions imposed by GoI, MoEF & CC, Integrated Regional Office, Bhubaneswar in their Stage-I/in-principle' approval order No. 5-ORC 470/2021- BHU dated 02.12.2021 and report on violation of FC Act, 1980 if any vide their letter under reference to this office immediately through your RCCF for onward transmission to Government of India, MoEF & CC, IRO, Bhubaneswar.
