With reference to the above cited memos on the subject, the Chief Conservator of Forests (Forest Diversion & Nodal Officer, FC Act), O/o. the PCCF, Odisha, Bhubaneswar has directed in condition No.(i) in his letter that, the user agency shall transfer the Net Present Value (NPV) of 5.858 Ha. forest land being diverted under this proposal, as per the Order of Hon'ble Supreme Court of India dated. 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007- FC dated.05.02.2009. the requisite funds shall be transferred through online portal in CAMPA account of the State concerned.

As per recent guideline of the GoI, MoEF & CC, New Delhi vide their Letter No. 5-3/2011-FC (Vol-I) dated. 06.01.2022 and subsequent clarification vide their letter dated. 22.03.2022, you are requested to deposit the differential amount of NPV Rs. 19,43,567/- (Rupees Nineteen lakh forty three thousand five hundred seven) only for 5.858 Ha. of area @ Rs. 9,57,780/- per Ha. in State CAMPA account. The RTGS receipt along with the UTR number in support of the above payment may please be submitted along with your compliance to this office for onward submission the same to the higher quarter.
