- i) In the Government of India letter 6th cited above, in the Stage-I approval, condition has been imposed for the realization of amount towards Net Present Value of forest land of 0.426 ha as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008 in IA No. 826 in 566 with related IA's in WP © No. 202/1995 and Ministry's guidelines No. 5-3/2011-FC(Vol.I) dated 06.01.2022 and clarification issued vide letter dated 19.01.202 and 22.03.2022.
- ii) In the Deputy Director, Mudumalai Tiger Reserve, Masinagudi reference cited, an amount of Rs. 30,60,105/- has been informed to the user agency towards Net Present Value of forest area.
- iii) As per the details uploaded under Part-II of Form-A, the proposed forest area of 0.426 ha comes under Mudumalai Tiger Reserve Sanctuary area and density of forest area is 0.30 and Eco-class of forest area is Eco-Class-III.

As per the above particulars, Net Present Value of forest area in the case of sanctuaries @ five times @ Rs. 9,57.780/- per ha has to be collected.

- iv) However, the Deputy Director, Mudumalai Tiger Reserve, Msainagudi has informed Rs. 30.60.105/- towards Net Present Value.
- v) Hence the amount mentioned in the verification of fund details in parivesh web portal is rejected and the user agency is requested to obtain fresh demand from the Deputy Director, MTR, Masinagudi Division and upload the verification of fund details freshly for further action.
