Sub : Forests – Forest (Conservation) Act 1980 – Hosur Forest Division – Proposal for diversion of 0.312ha of forest land in Cauvery North Wildlife Sanctuary area for laying of underground Optical Fiber Cable (OFC) along the road side of Dharmapuri-Anchetty road passing through Panai RF and Noganur RF in Hosur Wildlife Division, Hosur in the Krishnagiri District in favour of M/s Reliance Jio Infocomm Limited. In the Ref (2) cited above, the Government of India has conveyed stage-I approval with conditions and instructed to send compliance report for issuing final approval for diversion of 0.312 ha of forest land in Cauvery North Wildlife Sanctuary area for laying of underground Optical Fiber Cable (OFC) along the road side of Dharmapuri-Anchetty road passing through Panai RF and Noganur RF in Hosur Wildlife Division, Hosur in the Krishnagiri District in favour of M/s Reliance Jio Infocomm Limited. Mylapore, Chennai for the period of 20 years subject to conditions.

In continuation of this office letter cited in Ref (3) above, a revised demand was prepared for Net Present Value (NPV), based on the instructions issued by the Principal Chief Conservator of Forests (Head of Forests Force), Chennai in the Ref (4) cited above is as furnished below.

Therefore, the User Agency is requested to deposit the revised Net Present Value and submit the revised compliance report along with the following documents / details may be furnished to this office urgently for submitting compliance report to the Principal Chief Conservator of Forests.

In which, a part of the proposed alignment is passing through Panai Reserved Forest which falls inside the Cauvery

(vi)	As a part of the forest area proposed for diversion is forms part of Cauvery North Wildlife Sanctuary, the User Agency shall obtain approval from the competent authority under Wildlife Protection Act 1972 and from the competent authority under relevant act / rules / regulation for the area falls in the Eco Sensitive Zone. The State Government shall ensure all approvals required for the project before issuing of working permission, as the case may be.,	The User Agency shall obtain approval from the competent authority under Wildlife Protection Act 1972 and from the competent authority under relevant act / rules / regulation for the area falls in the Cauvery North Wildlife Sanctuary (0.27ha) and also for the area falls in the Eco Sensitive Zone of Cauvery North Wildlife Sanctuary.

(xiii)	The total forest area utilized for the project shall not exceed 0.312ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.	The User Agency will give necessary "Certificate" in this regard.
(xiv)	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.	The User Agency will give necessary "Certificate" in this regard.
(xv)	User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.	The User Agency will give necessary "Certificate" in this regard.
