In the Ref (2) cited above, the Government of India has conveyed stage-I approval with conditions and instructed to send compliance report for issuing final approval for diversion of 0.312 ha of forest land in Cauvery North Wildlife Sanctuary area for laying of underground Optical Fiber Cable (OFC) along the road side of Dharmapuri-Anchetty road passing through Panai RF and Noganur RF in Hosur Wildlife Division, Hosur in the Krishnagiri District in favour of M/s Reliance Jio Infocomm Limited. Mylapore, Chennai for the period of 20 years subject to conditions.

In continuation of this office letter cited in Ref (3) above, a revised demand was prepared for Net Present Value (NPV), based on the instructions issued by the Principal Chief Conservator of Forests (Head of Forests Force), Chennai in the Ref (4) cited above is as furnished below.
