ORDER:

In his letter 5th read above, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has requested the Government for diversion of forest land to an extent of **1.7926 ha (revised from 1.8680 ha)** in Medchal, Mahabubnagar, Amangal, Shamshabad and Vikarabad forest divisions of Medchal, Mahabubnagar, Rangareddy & Vikaraba districts respectively for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s Bharat Broad Band Network Limited.

2. Government, after careful examination of the proposal of the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad and in the light of the guidelines issued by the Government of India, Ministry of Environment & Forests, in the letters 2nd to 5th read above, hereby accord permission to the Principal Chief Conservator of Forests (HoFF), Telagana State, Hyderabad, for diversion of forest land to an extent of **1.7926 ha (revised from 1.8680 ha)** in Medchal, Mahabubnagar, Amangal, Shamshabad and Vikarabad forest divisions of Medchal, Mahabubnagar, Rangareddy & Vikarabad districts respectively for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s Bharat Broad Band Network Limited, subject to fulfillment of the following parameters / conditions:-

- i) The proposed work should be carried out without felling of trees and no cutting of branches is allowed;
- ii) The maximum size of the trench is 2.00 mtrs depth and 1.00 mtr width. Laid out along the road and within the existing right of way;
- iii) The User Agency to make good the land after use/ maintenance;
- iv) The User Agency to make good any loss to forests / environment;
- v) The User Agency should take permission for carrying out any maintenance; and,
- vi) The User Agency should pay compensation for the felled & damaged trees, if any.

(PTO)

- vii) The user agency is responsible for safe guarding the adjoining flora and fauna in the surrounding areas, and
- viii) Fixing of boundary pillars along proposed area on both sides of pipe line.
- ix) The NPV value as applicable shall be paid by the user agency upon stage-I approval for further processing of the proposal.
3. The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad shall take necessary further action, accordingly.


