No. 140, Kamatana Hobli, Bidar Taluka & district for construction of 4-lande Road over Bridge (ROB) and its approaches in lieu of existing level crossing No. 48/E at Km 66.900 on NH-50 (Railway Chainage 96/6-7) in favour of the Executive Engineer, Public Works, Ports & Inland Transport Department (National Highway Division), Kalaburagi. The Principal Chief Conservator of Forests, (HoFF), Bangalore has directed to the undersigned execute an agreement with the User Agency duly incorporating all the conditions imposed by the Government of India & Government of Karnataka and instructed to recover the balance payment of any recoverable as per the conditions of Stage-I & Stage-II.

As per ref (4) this office issued demand notice for difference amount NPV and compensatory planting (1:10) Charges vide Ref. (7) Dated: 20.04.2022.

Further, The Principal Chief Conservator of Forests, (HoFF), Bangalore has revised compensatory planting charges vide ref.(6) Dated: 24.05.2022.

This office has been issued demand notice as per the instruction of The Principal Chief Conservator of Forests, (Forest Conservation) & Nodal Officer (FCA), Bangalore more than one year passed your fail to remit difference amount as per demand notice and not executed an agreement with the forest department.
