Further, the following are the Compensatory levies to be paid by the user agency through e- payment mode as per the guidelines issued by the Adhoc- CAMPA , New Delhi Letter Dt.09.06.2016 and as per the guidelines issued in GoI, MoEF & CC( FC Division) F.No.5-3/2011-FC( Vol-I), Dt.06.01.2022 . **1(a) Procedure for e- challan generation:-**

- I. On issue of this notice, the user agency shall log in to Forest Clearance portal forestclearance.nic.in to generate e-challan and make payment against the demand.
- II. user agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- III. Once it is verified by the Nodal Officer, Agency can generate e-challan from the portal.

**1(b) Procedure for Payment through RTGS :-**

- IV. For payment through RTGS, the representation of the agency should visit his bank branch ( RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- V. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- VI. Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
