Government of Karnataka vide there letter cited at reference (1) has accorded in-principle Stage-1 approval for diversion of 1.4757 (revised from 1.9095) Ha. of forest land in Kadwad, Kinnar, Wailwada, Siddar, Belur, Bargal, Kove, Devalmakki, Naitisawar, Nivali, Kerwadi, Katar, Kadiye, Mallapur, Virje, Kuchegar, Hartuga, Kaiga and Majali village of Karwar taluk, Uttar Kannada District (Karwar Forest Division) for lying of OFC within the existing RoW in favoru of JIO Digital Fiber Private Limited, Bengaluru subject to conditions stipulated in the approval.

The same has been communicated by the Principal Chief Conservator of Forests, (Forest Conservation) and Nodal Officer, (FCA), Bengaluru vide his letter cited at reference (2) to this office for issuing 'demand notice' and submission of a 'Compliance Report'.


Accordingly, you are requested to make the payments shown hereunder and submit the 'Compliance Report' for all the conditions stipulated in the approval within 30 days.

As laid down in the condition No. 4 of the Govt. of Karnataka, the user agency has to provide signages in appropriate dimension and nature along the fiber cable within forest limits for sensitization of general public towards forest, wildlife and environmental issues. Hence, the Demand for following amount.
