2. The area involved has been declared as a Reserved Forest land vide Government of Gujarat Notification are as under.

1) AKH/1467/FLD/269/74105/P, date 09.10.1969

2) AKH/580/FLD/1669/63179/P, date 07.05.1970

3. This project will provide electricity to rural area.

4. 2023 trees are required to be cut in the demanded area. Girth and Species wise list of trees in enclosed.

5. User Agency have to transplant maximum number of trees under the supervision of concerned Deputy Conservator of Forest.

6. There is no violation of Forest (Conservation) Act, 1980 as Certified by the concerned Deputy Conservator of Forest.

7. The Project area Besaniya 4.00 km, Borkachchh 2.50 km & Chunawadi 0.150 km away from the Vansada National Park. However Chunawadi area falls in the Eco Sensitive Zone of the Vansada National Park. Chief Wildlife Warden, Gujarat State has given NOC vide letter No.PCCFO/0658/01/2023, dt.19.01.2023 and same is attached herewith.

8. User Agency has submitted undertakings to defray the Cost of Compensatory Afforestation, Net Present Value and any increase thereof.

9. Compensatory Afforestation is proposed at 16.00 ha degraded forest land at Survey No.38, Compartment No.136, Village-Sherula, Ta.Songadh, Dist.Tapi. Scheme of Compensatory Afforestation is enclosed herewith.

10. Site inspection report of the Project area is provided by the concerned Deputy Conservator of Forest.

11. User Agency has applied to Collector, Tapi for the compliance under the Forest Right Act, 2006. Application is attached herewith.

12. Addl. Principle Chief Conservator of Forest(Land) and Nodal Officer(FCA), Gujarat State, Gandhinagar has recommended to sanction the proposal.

13. Additional conditions of Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015 shall be applicable to this proposal. The user agency shall be bound to comply additional condition as per the aforementioned resolution and its amendment from time to time.

In the circumstances explained in the above paragraphs and enclosures, the Government recommends that the said forest land may be allowed to be diverted for the non-forestry use under Section-2 of the Forest (Conservation) Act, 1980.
