Madugula(M), Narsipatnam Division in favour of Executive Engineer, PIU, PR, Paderu - In-principle (Stage-I) approval accorded - Orders - Issued.

ORDER:

The Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh, in his letter 1st read above, while indicating the guidelines issued from time to time by the Government of India, Ministry of Environment, Forests & Climate Change, vide their letters 2nd read above, requested to accord Stage-I approval under Section-2 of Forest (Conservation) Act, 1980, for diversion of 1.88 Ha of forest land in Compt.Nos. 995,1003 & 1004 of Krishnapuram RL, Narsipatnam Division for formation and BT to the road including construction of culverts from Vanjari road to Korrapadu of G.Madugula(M), Narsipatnam Division in favour of Executive Engineer, PIU, PR, Paderu.

- 2. Government, after careful examination of the proposal and in exercise of the powers delegated by Government of India, Ministry of Environment, Forests & Climate Change, in the reference 2nd read above, hereby accord **in-principle(Stage-I)** approval for diversion of 1.88 Ha of forest land in Compt. Nos. 995,1003 & 1004 of Krishnapuram RL, Narsipatnam Division for formation and BT to the road including construction of culverts from Vanjari road to Korrapadu of G. Madugula(M), Narsipatnam Division in favour of Executive Engineer, PIU, PR, Paderu, subject to the following conditions:-
 - (i) The legal status of the forest land shall remain unchanged.
 - (ii) The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
 - (iii) The user agency shall pay the Net Present Value (NPV) of the diverted forest land as per the orders of the Hon'ble Supreme Court, dated.28-3-2008 and 9-5-2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No.202 of 1995 and as per the orders issued by Government of Andhra Pradesh vide Go.Ms.No.124, EFS&T (For.I) Department, Dated:27-7-2010.
 - (iv) The funds received from the user agency towards Net Present Value (NPV), under this project shall be deposited either in SB A/c No.SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC No.CORP0000371) or in SB A/c No.344902010105 407 Andhra Pradesh CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBINO534498).
 - (v) Additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency. The user agency shall furnish an undertaking to this effect.

- (vi) Other conditions specified in the Government of India, Ministry Environment, Forests & Climate Change, letters Dated.13-5-2011, and 10-12-2012. shall also be complied Conservator **Principal** Chief of Forests (Head of Forest Force), Andhra Pradesh, and user agency with which they are concerned.
- (vii) The total forest area utilized for the project shall not exceed **1.88 Ha** In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.
- (viii) After receipt of the compliance report of the above conditions, the proposal will be considered for final approval. Transfer of forest land to the user agency shall not be effected prior to the issue of final approval. This approval shall be valid for a period of 5 years. In the event of non compliance of the above conditions, this approval shall automatically stand revoked.
- (ix) Regarding any work in violation of the Acts and Rules, Regulations and guidelines in the matter, the user agency is liable for penal action as decided by the Government / Principal Chief Conservator of Forests (Head of Forest Force).
- 3. The Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh, shall take further necessary action accordingly.
