महाशय,

उपर्युक्त विषयक प्रासंगिक पत्र के सन्दर्भ में सूचित करना है कि Diversion of 51.251 ha. of forest land for construction of 220 KV/DC Ulijhari-Chaibasa to Gua Transmission Line in favour of JUSNL in West Singhbhum District, Jharkhand के वनभूमि अपयोजन प्रस्ताव पर भारत सरकार, पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय, क्षेत्रीय कार्यालय, रांची के पत्रांक FP/JH/TRANS/27672/2017-3377 दिनांक 22.08.2019 द्वारा सैद्धान्तिक स्वीकृति (Stage-I) प्रदान की गई है। उक्त स्वीकृत्यादेश में निहित शर्त संख्या 7(a) यथा “The user agency should conduct soil conservation activity under supervision of the State Forest Department” के अनुपालनार्थ आपके द्वारा समर्पित Soil & Moisture Conservation Plan की स्वीकृति प्रधान मुख्य वन संरक्षक, झारखण्ड, रांची के कार्यालय आदेश संख्या 133 दिनांक 01.09.2025 द्वारा दी गयी है। (छाया प्रति संलग्न)।

उक्त स्वीकृति आदेश के कंडिका-8 के बिन्दु संख्या (ii) यथा “That the total amount of Rs. 186.50 Lakh (One crore eighty six lakh and fifty thousand only) shall be deposited by the User Agency into CAMPA account under the relevant head/sub-head and shall be utilized by the State Forest Department through the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division as delineated under the Plan, strictly in accordance with the prevailing norms under the Jharkhand Forest Department.” के आलोक में अनुरोध है कि इस प्रमण्डल से संबंधित स्वीकृत राशि 139.96 लाख रुपये को e-portal (<https://parivesh.nic.in/>) के माध्यम से CAMPA मद में जमा करते हुए अनुपालन प्रतिवेदन तथा लागत राशि में किसी प्रकार की वृद्धि होने पर संशोधित दर से अतिरिक्त राशि जमा करने संबंधी शपथ पत्र अधोहस्ताक्षरी के कार्यालय में अविलम्ब समर्पित किया जाय ताकि अग्रेतर कार्रवाई की जा सके।

Sanction Order of the Soil and Moisture Conservation Plan with reference to
Diversion of 51.251 Ha. of forest land for construction of 220 KV D/C Uljhari-
Chaibasa to Gua Transmission Line in favour of JUSNL in West Singhbhum
district of Jharkhand.

The Instant Soil and Moisture Conservation Plan has been submitted by JUSNL,
Ranchi (referred to as "the Use Agency") in pursuance of the following
conditions laid by Regional Office, MoEF&CC, under Section 2 of Forest
(Conservation) Act, 1980 of condition no. 7(a) In-Principle Stage-I approvals vide
letter no. FP/JH/TRANS/27672/2017/3377 dated 22.08.2019 for non-forestry
use of 51.251 Ha. of forest land for construction of 220 KV D/C Uljhari-Chaibasa
to Gua Transmission Line in favour of JUSNL in West Singhbhum district.

The aforesaid Terms of Reference laid by the Central Government reads as
follows:

Compensatory afforestation:

*Stage-I Condition No. 7 (a) : "The User Agency should conduct soil conservation
activity under supervision of the State Forest Department."*

2. It was informed by the User Agency that in compliance of the above-mentioned conditions, the integrated Soil & Moisture Conservation Plan has

been prepared in consultation with the forest officials including DFO, Chaibasa Forest Division and DFO, Saranda Forest Division, Conservator of Forest (CF) Territorial Circle, Chaibasa, Regional Chief Conservator of Forest, Jamshedpur and Conservator of Forest, Admin, Ranchi.

3. In the above stated background, the Principal Chief Conservator of Forest-cum-Executive Director, Waste Land Development Board, Jharkhand, Ranchi vide his office letter no. 615 dated 17.07.2025 submitted the Plan to office of the undersigned for its consideration for sanction.
4. In order to examine the plan prescriptions, a communication was issued to the Regional Chief Conservator of Forests, Jamshepur, Conservator of Forest (CF), Territorial Circle, Chaibasa, DFO Chaibasa, Forest Division, DFO, Saranda, Forest Division and User agency, vide this office letter no. 1922 dated 13.08.2025 to arrange a Presentation of the plan in meeting scheduled on 19.08.2025 in the conference hall of the undersigned. The presentation was made by the Project proponent in the presence of Conservator of Forest, Admin, Ranchi, Regional Chief Conservator of Forests, Jamshepur, Conservator of Forest (CF), Territorial Circle, Chaibasa, DFO Chaibasa, Forest Division, DFO, Saranda, Forest Division, Sri Shayam Mahli, General Manager, JUSNL, Chaibasa, Sri Kuldeep Kumar, (TA to GM), JUSNL, Trans. Zone- VIII, Chaibasa, Sri Chandrakant Ojha, Consultant, Sri Gourav Kumar Singh, IGM, C&SA, Sri Sandeep Kumar Tirkey, DGM, JUSNL, Chaibasa, Sri Subroto Roy AGM, Project and Sri S.L. Gupta Sr. Manager were present during the presentation.

5. After deliberation on various provisions of the proposed Plan and the presentation, it was observed:

- i. The transmission line is located in two forest divisions, one Chaibasa Forest Division and Second Saranda Forest Division. The total length of the transmission line is 84.17 km. The Zone of Impact Area, as demarcated, encompasses an approximate geographical area of 708.05 sqkm. The total Forest Land diverted is 51.251 Hectares. The Forest area diversion in Chaibasa Forest Division is 42.133 hectares, while in Saranda Forest Division is 9.118 hectares. The Impact Area falls within the administrative jurisdiction of Chaibasa and Saranda Forest Division.
- ii. The project impact area is the surrounding region within the 4 kilometer buffer zone around the transmission line. The impact area comprises of total 201 villages, out of them 196 villages falls in Chaibasa Forest Division and remaining 5 villages falls in Saranda Forest Division.

6. The cost of the proposed 2-years Soil & Moisture Conservation Plan with respect to the activities to be carried out by DFO, Chaibasa Forest Division and DFO, Sanranda Forest Division have been estimated to be Rs. 186.50 lakh. The summary of the proposed interventions (component wise activities) under the Plan is as follows:-

Cost to the User Agency towards implementation of the SMC Plan is Rs. 186.50 Lakh.

7. The Plan with a total financial outlay of Rs. 186.50 Lakh extends over a period of 2 years and shall be utilized by the Forest Department through the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division in accordance with the Plan prescriptions.

8. Considering the proposals under the plan submitted by the User Agency and recommendation of the concerned forest officers, sanction is hereby accorded to the instant Plan subject to the following conditions:

(i) That the User Agency shall ensure that its officials/contractors and the work force engaged into mining and allied operations under the

Project shall not commit or abet any forest/wildlife offence in their area of operation. They will also promptly report any forest/wildlife offence in the area to the nearest forest office/official. Further, they will extend their full cooperation to the forest officials in control/mitigation of any incident, natural or man-made, determined to forest and wildlife in their area of operation.

- (ii) That the total amount of **Rs. 186.50 Lakh (One Crore eighty six lakhs and fifty thousand only)** shall be deposited by the User Agency into CAMPA account under the relevant head/sub-head and shall be utilized by the State Forest Department through the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division as delineated under the Plan, strictly in accordance with the prevailing norms under the Jharkhand Forest Department.
- (iii) That as regards the funds earmarked against activities to be undertaken by the State Forest Department, the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division shall prepare a detailed Annual Plan of Operations (APO) in the beginning of every financial year in respect of the instant Plan following all the rules, regulations, Schedule of Rates etc. issued from time to time by the State Government/Forest Department. Regional Chief Conservator of Forests, Jamshedpur shall supervise & closely monitor the progress of the activities undertaken by DFO, Chaibasa Forest Division and DFO, Saranda Forest Division as per the approved APO & funds released under CAMPA.

- (iv) That the Conservator of Forest (CF), Territorial Circle, Chaibasa shall supervise all the activities as per directions issued by the Forest Department from time to time.
- (v) That the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division shall carry out the activities under the Plan strictly as per the duly sanctioned APO.
- (vi) That above the DFO, Chaibasa Forest Division and DFO, Saranda Forest Division shall ensure that no violation of duly sanctioned Management Working Plans of their Forest Divisions takes place during implementation of any of the activities involved in this plan over notified and demarcated forest land.
- (vii) That the instant Plan is dynamic and be revisited after 1 year to assess its compatibility with mining and its concurrent reclamation activities and a revised Plan be formulated as per requirement.
- (viii) That though adequate provisions have been made towards cost escalation in the plan viz. increase in wage rate/material cost etc., yet the User Agency shall submit an undertaking to the Divisional Forest Officer, DFO, Chaibasa Forest Division and DFO, Saranda Forest Division to the effect that they will deposit extra cost of the plan beyond the cost escalation provision owing to increase in wage rate etc. in due course of time as well as consequent upon revision in the plan, if any, as and when given effect to by the competent authority.


