
**Sub:- Diversion of 7.8199 ha forest land for Widening and Strengthening of existing road to two lane with 1.5 m paved shoulder on either side from Km 35/700 to Km 71/120 of NH-220 of Rairangpur to Jashipur Section coming within Rairangpur & Karanjia Forest Division within the jurisdiction of Mayurbhanj District in the State of Odisha - Submission of revised Financial Outlay @ Rs.326/- regarding.**

In reference to the subject cited above, it is to inform that in the compliance report to Stage-I approval conditions submitted by you, the CA cost has been realized @ Rs.311/- per MD. Since the wage rate has been revised to Rs.326/- per MD, the revised financial outlay for Compensatory Afforestation Scheme over an area of 7.819 ha of Non-forest land identified in village **Ghodadega** in Kusumi Tahasil of your division pertaining to the above project has been approved by PCCF & HoFF, Odisha for Rs 39,90,600/- (Rupees thirty nine lakhs ninety thousand and six hundred) only which is enclosed.

You are requested to raise demand on the user agency for payment of the amount through web portal of MoEF & CC and submit the deposit particulars of the amount paid.


Further, you are also requested to furnish the revised statement of funds towards compensatory levies deposited by the user agency in the prescribed CAMPA format duly signed by you.

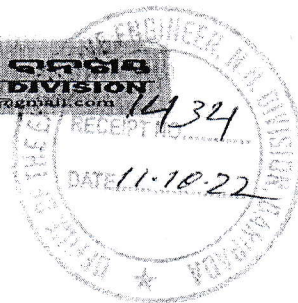

In inviting reference to the mentioned subject, it is to inform you that in compliance report of Stage- I approval conditions submitted by you, the Compensatory Afforestation Scheme has already been approved by PCCF & HoFF, Odisha & deposited by the U/A Rs 22,32,400/- realized @ Rs 311/- per MD. Now the wage rate has been revised to Rs 326/- per MD, so the revised financial outlay for CA Scheme over an area of 7.819 hec. of non-forest land identified in village Ghodadega in Kusumi Tahasil, the above project has been approved by PCCF & HoFF, Odisha for Rs 39,90,600/- (approval copy enclosed). Hence, the differential amount of Rs 17,58,200/- ( Rs 39,90,600 – Rs 22,32,400) Rupees Seventeen lakh fifty eight thousand two hundred only.

You are requested to deposit the differential amount in online CAMPA account and the copy of e-challan bearing seal and signature of the bank, UTR No. May please be sent to this office immediately for further needful action at this end.
