In continuation to this Office letter cited above, the Conservator of Forests (Nodal) Office of the Principal Chief Conservator of Forests, Odisha, Bhubaneswar has revised and technically approved the compensatory afforestation scheme over 41.725 ha of non-forest land identified in Village-Biswanathpur under Hemgir Tahasil and total financial outlay of the CA scheme of Rs.2,41,18,200/-(Rupees Two Crore Forty One Lakh Eighteen Thousand Two Hundred)only vide his Memo No.2244 dt.04.02.2022.

You have already paid Rs.63,90,700/-on dated.14.01.2016 and balance amount to be paid of Rs.1,77,27,500/-(Rupees One Crore Seventy Seven Lakh Twenty Seven Thousand Five Hundred) only ,hence, you are requested to deposit the differential amount of CA of Rs. Rs.1,77,27,500/-(Rupees One Crore Seventy Seven Lakh Twenty Seven Thousand Five Hundred) only through "E" payment mode by using the web portal of Ministry of Environment & Forests (CAMPA).
