Adverting to the subject and references cited above, it is informed that, the Government of India, Ministry of Environment, Forests & Climate Change, New Delhi vide reference 1st cited have accorded in-principle (Stage - I) approval for 1st Renewal for diversion of 124.00 (Surveyed 124.065 Ha) of Forest land for GKOC Phase-II, Kothagudem in Ramavaram Range of Kothagudem Division, Bhadradi Kothagudem District in favour of M/s Singareni Collieries Company Limited, Kothagudem.

The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide reference 2nd cited issued instructions to prepare demand note to the User Agency for payment of compensatory levies by the User Agency and for comply the condition nos. ii, vi, xviii and also ensure that the compliance conditions stipulated are complied which is mandatory for getting the Stage-II clearance for this Project and furnish the same through CCF, Warangal.

In this regard, as per the above report of the Conservator of Forests, Khammam, 17.50 Ha Bit is *Tropical dry Deciduous Dense Forests (Eco-class III)* and 106.50 Ha bit is *Tropical dry Deciduous open Forests (Eco-class III)* and as per Gol condition no.2, the user agency (M/s SCCL) has to deposit the amount towards Net Present Value (NPV). The mining lease area in *Tropical dry Deciduous Dense & Open Forests (Eco-class III)* as per latest NPV rates is Rs.12.28590 lakhs & Rs. 9.57780 Lakhs. The details of payment of compensatory levies to be made by the User Agency is as follows.
