Subject: Diversion of 2.89 ha. Private Forest land for construction of approach road (Expressway) to Mopa Air Port in Sy. No. 337, 339 & 340 in village Dhargalim, Pernem Taluk in North Goa District and Division in favour of Directorate of Civil Aviation, Secretariat Porvorim, Goa-reg.

Sir,

I am directed to refer to the State Government's letter No.6-856-20121-22-FD/Vol.1/288 dated 22/04/2021, and email dated 12<sup>th</sup> May, 2021 received from Dy. Conservator of Forest (M&E) Goa Forest Department seeking prior approval of the Central Government under Section '2' of the Forest (Conservation) Act, 1980 for the above project.

After careful examination of the proposal of the State Government, **in-principle approval /Stage-I clearance** of the Central Government is hereby granted for diversion of 2.89 ha of private forest land in Sy.No. 337, 339 & 340 in village Dhargalim, Pernem Taluk in North Goa Division and District for construction of approach road (Expressway) to Mopa air port in favour of Directorate of Civil Aviation, Secretariat, Porvorim, Goa subject to the following conditions:-

**A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.**

1. The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02. 2009. The requisite funds shall be transferred through online portal into CAMPA account of the State Concerned.
2. The identified non-forest land of 2.89 ha in Sy.No. 59/0, of Tuem village, of Pernem Taluk for raising Compensatory Afforestation (CA) shall be transferred and mutated in the name of forest department and notified as RF/PF prior to Stage II approval.
3. The proper KML file of the area identified for Compensatory Afforestation, Survey Sketch of the CA area and Compensatory Afforestation scheme shall be made

available prior to Stage-II approval.

4. The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The scheme may include demarcation of non- forest land using chain link fencing with provisions for watering, planting of taller (18 month old) seedlings, SMC works and escalation costs for works scheduled in subsequent years.
5. All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal (<https://parivesh.nic.in/>). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
6. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).
7. The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.
8. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019.

**B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:**

1. Legal status of the diverted private forest land shall remain unchanged.
2. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.
3. The User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department.
4. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
5. No labour camp shall be established on the forest land.
6. The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required.
7. The private forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the




Central Government.

8. No damage to the flora and fauna of the adjoining area shall be caused.
9. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
10. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
11. Permission to use/handing over of the land under proposal may be effected after the completion of the land acquisition process or after the settlement of the rights if any on the land.
12. The User Agency shall submit the annual self -compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Bangalore by the end of March every year.
13. The user agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

After receipt of compliance report on fulfilment of the conditions mentioned above, the proposal shall be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980. The User Agency shall take up the work as per the Guidelines in force and after ensuring that all necessary clearances for the entire stretch are in place.
