Sir,

With reference to the above-cited subject, it is to inform you that the Comprehensive Wildlife/Elephant Management Plan for the above project, with a financial outlay of Rs. 51,39,14,865/- (Rupees Fifty-One Crore Thirty-Nine Lakh Fourteen Thousand Eight Hundred Sixty-Five) only to be implemented by the Forest Department, has been approved by the Principal Chief Conservator of Forests, Wildlife & Chief Wildlife Warden, Odisha, Bhubaneswar vide his memo No. 3286 dt. 13.03.2024 (copy enclosed for your reference).

Besides, as per point No. A of the above-approved scheme to be implemented by the Project Proponent, the financial outlay for mitigation measures in the Angul Division is as given below:

i) A specialized vehicle for conflict management and animal rescue, as stated at Sl. No. 7.03, shall be procured and customized by the project proponent instead of depositing Rs. 60,00,000/- in the CAMPA Fund. (Purchase of 4x4 Pick-up for conflict management and animal rescue with customization: 20,00,000 x 3 Nos. = 60,00,000).

ii) A Mobile Veterinary Vehicle, as mentioned at Sl. No. 9.01, shall be procured and customized by the project proponent instead of depositing Rs. 70,43,242/- in the CAMPA Fund. (Establishment of "Mobile Veterinary Service" unit at Angul for 5 years (Procurement of vehicle and customization in the 1st year + yearly running cost)).

In this connection, you were requested to deposit an amount of Rs. 51,39,14,865/- - Rs. 20,00,000/- = Rs. 31,39,14,865/- (Rupees Thirty-One Crore Thirty-Nine Lakh Fourteen Thousand Eight Hundred Sixty-Five) only towards the cost of the Comprehensive Wildlife/Elephant Management Plan in the CAMPA account through e-payment immediately and intimate the deposit details to this office for further action vide this office letter No. 3336 dated 01.05.2024.

Further, as per the decision taken by the undersigned, the Tata Winger Ambulance 3200 was found suitable for the establishment of the "Mobile Veterinary Service" unit at Angul for 5 years.

Hence, you are requested to provide a Tata Winger Ambulance 3200 to this office at the earliest and deposit the balance amount in the account in favor of the Divisional Forest Officer, Angul Division, Angul. A xerox copy of the passbook front page is enclosed herewith for your reference as per the approval of the Comprehensive Wildlife/Elephant Management Plan.

Further, you are requested to provide 3 Nos of Mahindra Bolero Camper Gold ZX 4 x4 WD to this office at the earliest as per the approved comprehensive Wildlife/Elephant Management Plan. The vehicles will be customized as per the requirements of the Forest Department by a suitable vendor. After the customization is completed, you will be notified to make payment to the vendor for the vehicle customization.
