With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), Bangalore has accorded the final (Stage-II) approval for Diversion of Forest land over an extent of 5.1734 ha for Construction of 220 KV Transmission line from Badaladuku Sub-Station to Somalapura RPCL Project site in favour of M/s. Resource pellets Concentrates Private Limited, Sandur imposing certain conditions vide letter under Ref (1). Accordingly, the Government of Karnataka has accorded approval for diversion of the said forest land for the specified purpose for a period of diversion under this approval shall be 20 years or the project life, whichever is less vide letter under Ref(2).

Further, it is observed that, there is a revision in the watering charges [as per the Common Sanctioned Schedule of Rates (CSSR) in the year 2025-26] notified.
