Sir,

This is to inform in the above reference that since FCA proposal no. FP/DL/ROAD/525533/2025 is approved by Regional Office vide In-principle approval letter dated 30.04.202**1**.

Also, as per minutes of 1st REC meeting dated 12.01.2024 which is enclosed herewith, the previous CA land which has to be handed over by NHAI but due to some administrative reasons the said CA land was not handed over by NHAI to Department of Forests & Wildlife, Govt. of NCT of Delhi.

In lieu of the previous CA land, a 70 ha patch of double degraded forest land has been adopted in the said meeting which is approved and falls within the jurisdiction of West Forest Division.

Hence, it is mandate to deposit cost of Additional amount of CA through the online generated Challan on the web portal http://parivesh.nic.in of Ministry of environment, forest and climatic change, Govt. of India.

The revised estimate cost of CA over 70 Ha area in Pocket B of the Central Ridge is calculated as Rs. 80,07,53,100/- (Rupees Eighty Crore Seven Lakh Fifty Three Thousand and One Hundred). A copy of the revised and old estimate is enclosed herewith.

As per previous estimate the NHAI has deposited a cost of CA amounts to Rs. 35,39,27,907/- (Rupees Thirty Five Crore Thirty Nine Lakh Twenty Seven Thousand Nine Hundred and Seven Only).

Now, NHAI has to deposit the balance amount as Additional CA amount which is Rs. 44,68,25,193/- (Rupees Forty Four Crore Sixty Eight Lakh Twenty Five Thousand One Hundred and Ninety Three).

Hence, it is requested to deposit the additional CA amount as early as possible for the further course of action in the project.

Sub: Deposition of additional cost towards Compensatory Afforestation levies against proposal No.FP/DL/ROAD/48557/2020 for diversion of 35.16 ha forest land for construction of 6 lane access controlled highway from DND-Faridabad-Ballabhgarh Bypass junction with Delhi- Vadodara Expressway KMP-Interchange (NH-148 NA) under Bharatmala Pariyojana by NHAI -reg.

Sir,

Kind reference is invited towards D.O. letter dated 28.05.2025 addressed to the Chief Secretary, GNCTD wherein it has been requested that the proposal of carrying out Compensatory Afforestation (CA) on 70.32 ha Degraded Forest Land (DFL) as per eco restoration provisions within jurisdiction of NCT Delhi may be reconsidered.

As per Stage-I approval granted by MoEF&CC vide letter dated 06.04.2021, the CA was proposed to be carried out at Madanpur Khadar, Mehrauli (Non Forest Land) over an area of 35.16 ha. The CA scheme and demand note amounting to Rs.35,39,27,907.75/- which was issued at that time included the estimated cost for carrying out CA over 35.16 ha Non Forest Land at Madanpur Khadar (copy enclosed). The said cost was deposited by NHAI via PARIVESH portal on 26.05.2021. However, the said land parcel was not handed over to the Forest Department even after repeated requests. Thereafter, NHAI also requested that CA may be taken up in Kasganj, Uttar Pradesh which did not materialize.

In view of the Van (Sanrakshan Evam Samvardhan) Rules, 2024 notified on 20.09.2024, compensatory afforestation may be considered on degraded forest land which is twice in extent to the area proposed to be diverted in case of the Central Government agencies or Central Public Sector Undertakings or captive coal blocks of State Public Sector Undertakings on a case to case basis.

Hence, CA shall now be raised on 70.32 ha Degraded Forest Land (which is double in extent to the diverted area) in Pocket-B, Central Ridge by the Forest Department at the cost of NHAI as approved by the Regional Empowered Committee (REC) in its meeting held on 12.01.2024. The estimated cost of carrying out CA on 70.32 ha DFL as per the provisions of ecorestoration policy is Rs.80,07,53,100/- which was also approved by the REC, MoEF&CC in its meeting held on 12.01.2024 (Copy of Minutes & detailed CA scheme is enclosed).

In view of the above facts, it is requested that the additional amount of Rs.44,68,25,192.25/- towards CA may be deposited by NHAI in Delhi CAMPA fund in order to enable this Department to carry out CA on 70.32 ha DFL for which a demand note is being raised. After the above said amount is deposited, a compliance report may be submitted by NHAI for grant of Stage-II approval by the RO, MoEF&CC, Lucknow.

Diversion of 35.16 ha of Reserved Forest Land for construction of 6 lane access controlled Highway from DND-Faridabad-Ballabhgarh Bypass junction with Delhi-Vadodara Expressway KMP-Interchange (NH-148 NA) under Bharatmala Pariyojana by NHAI.

- The State Government vide letter No. 09/FCA/NHAI/2020-21, dated 17.02.2021 had submitted the proposal for approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980
- 2. The proposal was submitted before REC meeting held on 23.03.2021 as Agenda Item 54.9-Delhi, the REC was recommended the proposal for approval. This office vide letter No. 8B/Delhi/06/02/2021, dated 06.04.2021 issued in-principle approval on certain conditions. "Compensatory afforestation shall be taken up by the forest department over 35.16 ha non-forest land in Compartment/Khasra/Survey No. 871(62-2), 872(6-0), 875(331-15), 876(14-7) and 877(8-10), village Madanpur Khadar, Range Merauli, District Delhi South-East at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. The Forest Department and Wildlife, New Delhi vide letter No. 09/FCA/NHAI/2020-21/6270-74, dated 28.11.2023 stated that the matter under consideration is regarding the change in compensatory afforestation land against the project. In this regard it is hereby informed that NHAI has not handed over 35.16 ha non-forest land identified for CA till date based on which the Stage-I permission was granted on 06.04.2021.
- 4. The General Manager (T) & Project Director, CMU, Mathura vide letter dated 22.03.2023 informed that the user agency is unable to hand over the said parcel of land measuring 35.00 ha in Madanpur Khadar based on which Stage-I approval was granted. Further, CA land has been identified in Kasganj district of Uttar Pradesh. The user agency requested vide letter dated 22.03.2023 that the said parcel of land may be considered for CA purpose as such a big chunk of land is not available in Delhi.
- 5. The said request of NHAI could not be considered as a similar request of NHAI for identification of CA land outside Delhi was submitted to the Govt. of NCT of Delhi which was not agreed to by the Government.
- 6. The issue of providing compensatory afforestation (CA) land of 70.32 ha against NHAI was discussed in the meeting held under the Chairmanship of the PCCF/HoD, GNCTD dated 19.06.2023. It was pointed out that DCF South has informed that one year working permission granted by his office has expired and the NHAI has not taken up the matter for second year working permission which is to be granted by IRO, MoEF&CC, Jaipur. Further, the CA land has been identified by NHAI at district Kasganj, Uttar Pradesh for which approval of DM for 35.107 ha land has been submitted. However, the CA scheme etc. is yet to be processed by the local DFO. In view of the urgency for identification of CA land, the proposal of NHAI to identify degraded forest land in ridge area in Delhi may be considered. It was agreed in-principle that DCF (West) may identify and submit eco-restoration proposal of the double degraded forest land as per the eco-restoration

policy adopted by the Delhi Forest Department and submit the same for consideration. This is in accordance with the provisions of Chapter-2, Section 2.5(i)(f) of the guidelines 2019 issued under Forest (Conservation) Act, 1980

- 7. Accordingly, the DCF (West), Delhi vide letter dated 16.11.2023 submitted the CA scheme and details of 70.00 ha area of forest land identified in Pocket B of the Central Ridge for purpose of compensatory afforestation land through Eco-Restoration strategy duly approved Delhi Eco-Restoration Policy by the Cabinet vide order No. F03/7/2020/GAD/CN/dsgadiii/561-570 dated 29.01.2021
- 8. The revised estimate cost of CA over 70.00 ha area in Pocket B of the Central Ridge is calculated as Rs. 80,07,53,100/- (Rupees Eighty Crore Seven Lakh Fifty Three Thousand & One Hundred only), estimate attached.

with abundance of Keekar. Hence, Compensatory Afforestation cannot be done without Eco-

Restoration.

The Cost of Plantation and 07 Years Maintenance of Tree Sapling is Rs. 5700/-

(Rs. Five Thousand Seven Hundred Only) per sapling.

(Rs. Three Thousand Four Hundred Twenty Only) per sapling.

• The Cost of Plantation and 07 Years Maintenance of Climber Sapling is **Rs. 3420/-**

01 Kikkar Tree (2 Climbers, 2 Shrubs and 4 Native Trees). Therefore, 1,06,400 Saplings
