With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), Bangalore has accorded In-principal / Stage-I clearance approval for diversion of 0.32 ha of Forest land to access existing Approach Road to ML No.2545 in Jaisingapura Village, Ramanamalai Forest Block, Sandur taluk Ballari District in favour of M/s. Lakshmi Minerals, Hospet imposing certain conditions vide letter under Ref (1). In this regard, the Government of Karnataka has also directed to submit compliance report to conditions stipulated in Stage-I approval vide letter under Ref(2).

Further, the Principal Chief Conservator of Forests (Forest Conservation) & Nodal officer, Bangalore has directed the User Agency to make all statutory payments (Net Present Value, Compensatory and other stipulated charges) mentioned in Stage-I approval through Government of India web portal and also directed the undersigned to issue the Demand Notice to User Agency as per conditions stipulated by Government of India vide letter under Ref(3). In this regard, the office of the undersigned has issued demand notice to an extent of 0.64 ha for CA charges vide condition No.A(2) vide letter under Ref (6).

Further, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), Bangalore has issued subsequent following modification of the condition No.A-2 vide letter Dt.28/29.07.2022 under Ref(1).

"(A)2. The identified non-forest land of 0.32 ha in Sy.No.92, Kallahalli Village, Hospete Taluk for Raising of Compensatory Afforestation(CA) shall be transferred and mutated in the name of the forest department and notified as RF/PF prior to Stage-II approval"
