- 2. I wish to inform that the User Agency i.e. Sri Dara Appa Rao, Yadavolu (V), Devarapalli (M), West Godavari District has furnished justification stating that they have explored all alternatives and found no deposits of the mineral outside the RF and applied area is the barest minimum. The proposed project is to quarry a particular variety of road metal which is uniquely available in the applied forest area and not available anywhere outside. The Divisional Forest Officer, Guntur has certified that the User Agency has not violated the provisions of Forest (Conservation) Act, 1980. The District Collector, Guntur District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded on the Ministry's website and unique file No. FP/AP/QRY/37853/2018 has been generated. The concerned Divisional Forest Officer, the Conservator of Forests and the Principal Chief Conservator of Forests (Head of Forest Force), have recommended the proforma proposal in Part-II, III and IV respectively.
