I enclose herewith a copy of the letter cited along with statutory proforma proposal submitted by the Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh, for diversion of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecherla (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in favour of Sri Kunam Brahmananda Reddy, Ongole, Prakasam District, under Forest (Conservation) Act, 1980.

2. I wish to inform that the User Agency i.e. Sri Kunam Brahmananda Reddy, Ongole, Prakasam District has furnished justification stating that they have explored all alternatives and found no deposits of the mineral outside the RF and applied area is the barest minimum. The proposed project is to quarry a particular variety of Road Metal which is uniquely available in the applied forest area and not available anywhere outside. The Divisional Forest Officer, Guntur has certified that the User Agency has not violated the provisions of Forest (Conservation) Act, 1980. The District Collector, Guntur District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded on the Ministry's website and unique file No. FP/AP/QRY/37852/2018 has been generated. The concerned Divisional Forest Officer, the Conservator of Forests and the Principal Chief Conservator of Forests (Head of Forest Force), have recommended the proforma proposal in Part-II, III and IV respectively. The recommendations of State Government in proforma proposal in Part- V is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under section 2 of Forest (Conservation) Act, 1980, for diversion of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecherla (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in favour of Sri Kunam Brahmananda Reddy, Ongole, Prakasam District, at an early date.
