Sub: Thiruvananthapuram Forest Division - Diversion of forest land for the up gradation of 9.93km existing 66KV Attingal - Palode SC feeder to 110KV Double Circuit from Mithirmala to Palode - Demand notice - reg.

Attention is invited to the subject and reference cited. In-principle approval/ Stage-I clearance of the Central Government under section 2 of Forest (Conservation) Act,1980 for the diversion of 7.414 Ha of forest land for the up gradation of 9.93km existing 66 KV Attingal - Palode SC feeder to 110 KV Double Circuit from Mithirmala to Palode has been accorded subject to the fulfilment of certain conditions vide reference (1) cited above. As per the conditions 1 and 2 in the order cited (1) above, the NPV and cost of Compensatory Afforestation is calculated as below.

1. Net Present Value of the 7.414 Ha of Forest land (Eco Class I Dense Forest) as per the File No.5-3/2011-FC(Vol-I) dated 06.01.2022 of MoEFC(FC Division) - $7.414 \times 14,36,670/- = \text{Rs.1,06,51,471.38/-}$
2. Cost of Compensatory Afforestation (Cost of restoration of 15 Ha degraded forest land in Ananthan Estate of Kallar section in Palode Range)
 $= \text{Rs.27,80,000/-}$

Total = Rs.1,34,31,472/- (Rupees One Crore Thirty Four Lakhs Thirty One Thousand Four Hundred and Seventy Two Only).

The NPV and cost of CA has to be paid in CAMPA account only through e-portal (<https://parivesh.nic.in/>) as per the condition 5 in the Stage-I clearance order cited (1) above. Hence it is requested to pay the above amount as NPV and cost of CA and upload the compliance report in the e-portal after complying all the conditions in the order under intimation to this office. The proposal shall be considered for final approval under section 2 of the Forest (Conservation) Act only after submitting the compliance report.
