With reference to the above correspondences concerning the captioned subject, this is to inform you that the revised Net Present Value (NPV) of the Forest Land diverted which comes under Eco-Class-I with a Density of 0.5 comes to Rs 7,00,84,000.00 (Rupees Seven-Crore Eighty-Four Thousand) only and the Penal NPV to Rs 1,66,55,000.00/- (Rupees One-Crore Sixty-Six Lacs Fifty-Five Thousand) only. The calculation of the NPV & the Penal NPV is mentioned below;

Note: 1st Violation is from 07.03.2019 to 27.11.2024 & 2nd Violation is from 01.04.2022 to 27.11.2024.

As per Serial No. 3 (i) User Agency shall transfer the funds towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 06.01.2022 read with 22.03.2022 through online portal of CAMPA account of the State Concerned; (ii) At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India; & Serial No. 7 i.e. The State Govt. shall realize Penal NPV of forest land per ha per each year of violation from the date of actual diversion as reported by the inspecting officer with maximum up to 5 times the NPV plus 12% simple interest from the date of raising of such demand till the deposit is made; Hence, you are, requested to make the payment for the Net Present Value (NPV) for the above-mentioned project amounting to Rs 7,00,84,000.00 (Rupees Seven-Crore Eighty-Four Thousand) only and the Penal NPV to Rs 1,66,55,000.00/- (Rupees One-Crore Sixty-Six Lacs Fifty-Five Thousand) only in State CAMPA Fund through Parivesh Portal (<https://parivesh.nic.in/>) immediately and report the undersigned about deposit of the same for taking further action at this end.


Sir,




