DEMAND NOTICE

Sub: TSFD- F(C)Act, 1980 - Proposals for diversion of Forest Land to an extent of **1.5194** ha in Mahadevpur forest division of Jayashankar Bhupalpally District in favour of M/S Reliance Jio information Limited for laying of Optical Fiber Cable along the road and within the existing Right of Way - Demand notice issued- Reg.

The Prl. Chief Conservator of Forests (HoFF), TS, Hyderabad vide reference 2nd cited above has communicated that, the State Government vide reference 1st cited above has accorded in-principle (Stage-I) approval for diversion of Forest Land to an extent of 1.5194 ha in Mahadevpur forest division of Jayashankar Bhupalpally District, for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s. Jio Digital Fibre Private Limited (earlier M/S Reliance Jio information Limited) (user agency).

Further, it is submitted that, the Prl. Chief Conservator of Forests, (HoFF), TS, Hyderabad has further requested to issue the demand notice to the User Agency as per the condition stipulated and submit through mail for vetting by the Nodal Officer. The details are as follows.

The User Agency is requested to deposit the compensatory levies towards CA, NPV etc., into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire Forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the Forest clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further, the User Agency is requested to furnish undertakings on C. No. 3(i), (iv), (vi), (viii) to (xxiii).

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

Therefore, the M/s. Jio Digital Fiber Ltd., Hyderabad is requested to deposit the Compensatory levies towards CA, NPV etc., duly following the procedure mentioned above and submit Stage-I compliance report immediately for obtaining Stage-II approval.
