Kindly refer the letter in the reference where in principle approval has been accorded to the captioned project subject to certain conditions.

- A. As per condition No.04&09 of the said letter,
 4. "A site Specific Wildlife Conservation Plan duly approved by CWLW shall be prepared and same shall be implemented at the cost of user agency".
 9. "The state will also prepare a human elephant conflict mitigation plan which will be funded by the User Agency and will take necessary measure to mitigate drivers of negative human elephant conflicts and paying timely compensations and ex-gratia.;
- B. In compliance of the above-mentioned condition of stage-I approval a Site-Specific Wildlife Conservation Management & Mitigation Plan was prepared by User Agency and submitted before Principal Chief Conservator of Forest, Wildlife & Chief Wildlife Warden, Jharkhand, Ranchi for approval of the same. The said plan has been approved vide office order no-04 dated- 06.02.2025 of PCCF, Wildlife & Chief Wildlife Warden, Jharkhand, Ranchi wherein, a provision **Rs 3524.74 Lac** have been made for implementation of the plan against mining activities for Chatra South Forest Division.
- C. As per MoEF&CC guideline F No.FC-11/43/2021-FC dated 07th June 2022, User Agency has already deposited the lump sum amount(i.e 2 % of project cost) Rs. 19,47,00,340.00 (Nineteen crore Forty-Seven lac Three hundred Forty only) towards Wildlife Conservation Management & Mitigation Plan.
- D. Therefore it is requested to deposit remaining amount i.e **Rs 15,77,73,660.00** (Fifteen crore Seventy-Seven lac Seventy-Three thousand Six hundred and Sixty only) in CAMPA Account. Kindly refer the letter in the reference where in principle approval has been accorded to the captioned project subject to certain conditions.

- A. As per condition No.12 of the said letter,
The User Agency either himself or through State Forest Department shall undertake gap planting and soil & moisture conservation work to restock and rejuvenate the degraded open forests (having crown density less than 0.4) if any located in the area within 100 meters from the outer perimeter of mining lease. The plan for plantation and SMC activities will be prepared and submitted to MOEF&CC before Stage-II clearance.
- B. In compliance of the above-mentioned condition of stage-I approval a Site-Specific Soil Moisture Conservation Plan was prepared by user agency and submitted before Principal Chief Conservator of Forest, Jharkhand, Ranchi for approval of the same. The said plan has been approved vide office order no-171 dated- 28.11.2024 of PCCF, Jharkhand, Ranchi wherein, a provision **Rs 3760.86 Lacs** have been made for implementation of the plan against mining activities for Chatra South Forest Division.
- C. As per MoEF&CC guideline F No.FC-11/43/2021-FC dated 07th June 2022, User Agency has already deposited the lump sum amount(i.e 0.5 % of project cost) Rs. 4,86,75,085.00 (Four Crore Eighty-Six lac Seventy-Five Thousand Eighty-Five only) towards Site-Specific Soil Moisture Conservation Plan.
- D. Therefore it is requested to deposit remaining amount i.e **Rs 32,74,10,915.00** (Thirty-Two crore Seventy-Four lac Ten thousand Nine hundred and Fifteen) in CAMPA Account. The amount should be deposited to CAMPA Fund only through e-portal (<https://parivesh.nic.in>) and copy of challan/receipt shall be sent to this office for records.
