Whereas the Stage-I approval over 5.888 ha. forest land in respect of Oraghat Iron & Manganese Mines of M/s Sayed Abdul Halim has been granted by the MoEF & CC. IRO, Bhubaneswar vide Letter under reference (1).

And whereas the Lessee has already deposited ₹42,98,240/- towards NPV over 5.888 ha. of entire forest land @ ₹7,30,000/- vide D.D. No.129969 dt.10.6.2010.

And whereas on Site Inspection by undersigned, the canopy density over 5.888 ha. of forest land proposed to be diverted vide the above said proposal has assessed as 0.4, Eco-Value Class-I, the NPV need to be charged @₹14,36,670/- per hectare over the applied forest area of 5.888 ha. for diversion, i.e. 5.888 ha. x ₹14,36,670/- = ₹84,59,113/-

And whereas out of the above assessed amount you have already deposited ₹42,98,240/- @ ₹7,30,000/- per hectare over the said area of 5.888 ha.

Now therefore, the undersigned, by virtue of authority vested by the Apex Court, hereby demand for payment of ₹41,60,873/- (₹84,59,113/- (-) ₹42,98,240/-) towards differential NPV over 5.888 ha. of forest land within 30 days of issue of this Order.

The NPV of ₹ 41,60,873/- (Rupees Fourty One Lakhs Sixty Thousand Eight Hundred Seventy Three only) is to be deposited through e-portal of MoEF & CC as provided in the <a href="http://parivesh.nic.in">http://parivesh.nic.in</a>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

It is further ordered that in the event of upward revision of NPV, an undertaking to pay the differential amount is to be submitted by the Lessee.


