বিষয়: Diversion of 1.84 ha. protected forest land for construction of cluster bus depot at East Vinod Nagar by Transport Department, Govt. of NCT of Delhi-reg.

महोदय,

कृपया उपरोक्त विषय पर मुख्य वन संरक्षक एवं नोडल अधिकारी, एफसीए, नई दिल्ली का पत्रांक— 11/PS/PCCF/FCA/Vinod Nagar/2019/4241-44, दिनांक—10.06.2019 का आशय ग्रहण करने का कष्ट करें जिसके द्वारा राज्य सरकार ने विषयांकित प्रस्ताव पर वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति मॉगी थी।

प्रश्नगत प्रकरण में प्रस्तुत अनुपालना पर विचारोपरान्त मुझे मुझे यह सूचित करने का निर्देश हुंआ है कि केन्द्र सरकार ट्रांसपोर्ट डिपार्टमेन्ट को विनोद नगर (पूरब) में क्लस्टर बस डिपो के निर्माण एवं 175 वृक्षों के पातन (143 हरे एवं 32 सूखे) की सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department over 1.84 ha. of non forest land (Compartment no./ Khasra No. Nil, Village-Malikpur, Tehsil-North, District-Delhi) at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- 3. The non-forest land shall be transferred and mutated in favour of the State Forest Department.
- 4. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance in the CAMPA Fund by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 5. The State Government shall charge the Net Present Value(NPV) for the 1.84 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.

- 6. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 7. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 8. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 9. Muck disposal scheme sanctioned by DFO should be submitted.
- **10.** Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 11- Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 12- No violation certificate from concerned DFO shall be provided.
- 13- Compliance of clause 11.2 of FCA guidelines shall be ensured and in no case, forest land shall be used for non-forestry purpose till final approval is granted.
- **14.** All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through *e-portal* (https://parivesh.nic.in/).
- 15. CD of kml files has to be submitted.
- 16. Certificates of no alternative suitable Non Forest Land for the project minimum demand of forest area have to be countersigned by concerned DFO & provided in original.
- 17. The compliance report shall be uploaded on *e-portal* (https://parivesh.nic.in/).
