With reference to memo cited above on the captioned subject, it is to inform you that the Financial outlay for CA Scheme over an area 59.012 ha. of degraded forest land identified in Kunjam RF under Deogarh Forest Division pertaining to the above project amounting to Rs.78,50,200.00/- (Rupees Seventy \Eight Lakh Fifty Thousand Two Hundred) only has been technically approved by Addl. PCCF (FD & No, FC Act) at the wage rate of Rs.298/- Man day with 10 years maintenance. This fund was deposited by you vide reference ID SBINR 52020092800028147 dt.28.09.2020 as communicated to this office vide your Letter No.1032 dt.28.09.2020.

Due to revision of wage rate from Rs.298/- MD to Rs.315/- MD the above financial outlay of CA Scheme has been revised and technically approved by CCF (FD & NO, FC Act) for Rs.1,23,78,500/- (One Crore Twenty Three Lakh Seventy Eight thousand Five Hundred) only. The Technically approved letter is enclosed herewith for your information.

Therefore, you are requested to deposit the differential amount of (Rs.1,23,78,500.00-78,50,200.00) = Rs.45,28,300/- (Rupees Forty Five Lakh Twenty Eight Thousand Three Hundred) Only against CA for payment through web portal of MoEF & CC and submit the deposit particular in CAMPA format to this office for taking further action at this end.
