Read 1 Letter No. FCI-14785/2017 dated 11/10/2019 from the Principal Chief Conservator of Forest (Forest Management) & Nodal Officer.

### <u>O R D E R</u>

The Principal Chief Conservator of Forest (Forest Management) & Nodal Officer as per letter read above has recommended and forwarded the proposal for diversion of 0.0110 ha of forest land under Section 2 of Forest (Conservation) Act, 1980 for electrification of Thannipoyil area in Malappuram District in Edavanna Range of Nilambur (North) Division. The Assistant Engineer, Electrical Section Office, KSEBL, Akambadam is the user agency. The proposal is for providing electricity connection in Thannipoyil forest area in Akambadam Village of Malappuram District. The area comes under the jurisdiction of Nilambur (North) Division. The proposal is beneficial for the houses of this area.

2. Government have examined the proposal in detail and are pleased to accord sanction for the above proposal subject to the following conditions:-

- i. Legal status of the forest shall remain unchanged.
- ii. The User Agency shall give undertaking to pay Net Present Value as per guidelines issued by Government of India.
- iii. The User Agency shall give an undertaking to pay additional Net Present Value if required.
- iv. The User Agency shall not fell any trees or cause damage to the surrounding forest and shall take all possible measures to conserve tree growth.
- v. The User Agency shall not use the forest land for any purpose other than the purpose for which the forest land is diverted.
- vi. When the forest land is no longer required for the purpose, the land will be resumed back to the Forest Department.
- vii. The User Agency shall abide by any other condition imposed later on by Government of India/Government of Kerala/Forest Department in the

interest of Forest Conservation.

- viii. The User Agency has to check the LT Single Phase OH insulated cable in regular interval with permission from Divisional Forest Officer to prevent any danger to wildlife.
  - ix. The User Agency shall apply for renewal of approval after 20 years.
  - x. The User Agency has to sign an agreement with Divisional Forest Officer, Nilambur (North) incorporating all the conditions imposed by Government of India/Government of Kerala/ Kerala Forest Department in this regard and a nominal lease rent as decided by the Government of Kerala may be remitted.
