Sir,

As per the power conferred under Order F. No. 11-9/98-FC dated 07.11.2014 by the Ministry of Environment and Forests, New Delhi the request of the Executive Engineer (Irri.), PWD Civil Division No. III, District Panchayat, Dadra & Nagar Haveli, Silvassa for Diversion of 0.066 Ha. Reserved Forest Land for Construction of Approach Road from Rudana Maragpada to Samsan in the U.T. of Dadra & Nagar Haveli is considered and **In-principle approval** is accorded subject to the following conditions:-

- xiii. The User Agency shall transfer/deposit ₹ 96,219/- (Rupees : Ninety Six Thousand Two Hundred Nineteen only) towards Compensatory Afforestation including maintenance for 10 years and ₹ 61,974/- (Rupees: Sixty One Thousand Nine Hundred Seventy Four only) towards Net Present Value of the land (NPV).
- xiv. The forest land shall not be used for any other purpose other than that specified in the proposal.
- xv. The compliance report shall be uploaded on e.portal (<http://forestsclearance.nic.in>).

You are therefore, requested to deposit ₹ 1,58,193/- (Rupees: One Lakh Fifty Eight Thousand One Hundred Ninety Three only) through challan generated online mode in favor of Compensatory Afforestation Fund (CAF) Dadra & Nagar Haveli and copy of proof / evidence may be submitted to this office. The User Agency shall adhere to all the conditions indicated above.

The formal order for diversion of forest land to the User Agency will be issued after above conditions is complied. In no case the work shall be started without a formal order from this office.
