With reference to the letter cited above on the captioned subject, it is to inform you that the Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha had approved the financial out lay of Rs 48,96,200/- (Rupees Forty-Eight Lakh Ninety-Six Thousand Two Hundred) Only towards Compensatory Afforestation scheme over an area of 25.0 ha of degraded forest land identified in Panchhikote DPF under Jajpur Road Range of Cuttack Forest Division against the above project as per wage rate of Rs. 308/- per Manday with 10 years maintenance.

Now, the Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha has revised the financial out lay of Rs 67,68,500/- (Rupees Sixty-Seven Lakh Sixty-Eight Thousand Five Hundred) Only as per current wage rate of Rs. 315/- per Manday with 10 years maintenance.

Hence, you are requested to make an arrangement for payment of differential amount of Rs. 18, 72, 300/- (Rupees Eighteen Lakh Seventy-Two Thousand Three Hundred (Rs.67, 68,500.00 – Rs.48, 96,200.00) only with the Adhoc Body of CAMPA through the e-payment module and submit required evidence in respect of the payment to this office for reference and onward transmission.
