Wherein the Government of Tamil Nadu has conveyed the Government's in Principal approval (Stage – I) under section 2 (1) (ii) of Van (Sanrakshan Evam Samvardhan) Adhiniyam.1980 for diversion of 0.09 Ha of Forest land in Semakottai Reserved Forests of Cuddalore Division for widening of road from Single lane to Double lane and improvement of Vridhachalam to Kattukudalore road from km 10/6 to 11/6 in Cuddalore District. Favour of The Assistant Divisional Engineer, Highways, Construction and Maintenance Sub Division, Vridhachalam. Cuddalore District period of 20 years, subject to the follow us condition
