Sub: TSFD – Forest (Conservation) Act, 1980- Diversion of 13.6417 ha (8.98745 ha in Nirmal division and 4.65425 ha in Khanapur division) (restricted from 13.945 ha (9.038 ha in Nirmal Division and 4.907 ha in Khanapur Division)) of forest land for Widening and Strengthening of existing intermediate lane/two lane to two lane with paved shoulders from km 678+ 555 to km 699+655 of Nirmal to Khanapur section of NH 61 Extended – in the state of Telangana under NH(0) through EPC mode in favour of the regional Officer, MORTH, Hyderabad – In-principle (Stage-I) approval - Accorded – Demand Notice Issued – Further instructions issued - Regarding.

It is to inform that, the Government of Telangana has accorded in-principle (Stage-I) approval for Diversion of 13.6417 ha (8.98745 ha in Nirmal division and 4.65425 ha in Khanapur division) of Forest Land for widening and strengthening of existing intermediate lane / two lane to two lane with paved shoulders from km 678+555 to km 699+655 of Nirmal to Khanapur Section of NH-61 extended in the State of Telangana under NH (0) through EPC mode in favour of Regional Officer, MORTH, Hyderabad” has been communicated by the Prl.CCF(HoFF) vide reference 2nd and 4th cited for raising of demands over the Regional Officer, MORTH, Hyderabad (user agency) for making payment of compensatory levies and to obtain the compliance report on the conditions stipulated by the MoEF&CC, GoI, from the user Agency.

Further it is to informed that, as per the instructions issued by the Prl. Chief Conservator of Forests, TS, Hyderabad, the Forest Divisional Officers Nirmal and Khanapur are prepared and issued the demand notice to the User Agency (UA) in consultation with Nodal Officer, FCA for making payment of Net Present Value (NPV), Cost of CA, Wildlife Conservation plan, cost of construction of Boundary Pillars and Extraction of the Tree Growth etc., vide reference 5th and 6th cited.

It is further informed that, the Principal Chief Conservator of Forests (HoFF), Aranyabhavan, Telangana State, Hyderabad vide reference 7th cited has informed that, the IRO, Hyderabad has recently in others projects have requested for transferring the funds deposited into BIOSAT Account to the Ad-hoc CAMPA Account, as per the CAF Rules.

In view of the above, the UA is requested to deposit the following amount towards mitigation measures and construction of Canopy bridge into Ad-hoc CAMPA Account along with CA and NPV, as per the CAF Rules. The details are as follows:
